Thank you for lodging your Campaign Donation return.

The Act requires all returns (apart from returns lodged from 7 February onwards during the designated period) to be lodged with an audit certificate (unless it is a nil return), unless a waiver is sought and granted by the Electoral Commissioner.

I have enclosed a copy for your information.

Section 130ZV(4) of the Act provides that the Electoral Commissioner may waive compliance with the requirement to provide an audit certificate if he considers the cost of compliance with the requirement would be unreasonable.

I would be grateful if you would complete the audit certificate or seek a written exemption.
