#### **Definitions:**

Elector	a person whose name appears on the roll as an elector (not being a person under the age of 18 years who is provisionally enrolled) and includes a person whose name should appear on a roll as an elector but has been, by error, omitted from the roll (section 4 of the <i>Electoral Act 1985</i> ).
Foreign country	see definition in the Acts Interpretation Act 1901 (Commonwealth).
Foreian nerson	see definition in the Foreian Acauisitions and Takeovers Act 1975

*Foreign person* see definition in the *Foreign Acquisitions and Takeovers Act* 1975 (Commonwealth).
