## **Application for Waiver of Audit Certificate**

#### **BACKGROUND**

Registered political parties are required to lodge returns every 6 months. To be a complete return it must be accompanied by an Audit Certificate.

Section 130ZV(4) provides that the Electoral Commissioner may waiver compliance with the requirement to provide an audit certificate if

(a) in the case of a return, it is a nil return

(b) in any case if the Electoral Commissioner considers the cost of compliance with the requirement would be unreasonable.

#### DISCUSSION

The party agent for the Stop Population Growth Now Party has lodged an Application for Waiver of Audit Certificate on the grounds that the cost of compliance would be unreasonable because the audit certificate would cost \$2,000 which would almost exhaust the total funds of the party (\$3,395).

### RECOMMENDATION

That you approve the application by the Stop Population Growth Now Party for a waiver of the obligation to lodge an audit certificate on the grounds that the cost of compliance would be unreasonable
