a person whose name appears on the roll as an elector (not being a person under the age of 18 years who is provisionally enrolled) and includes a person whose name should appear on a roll as an elector but has been, by error, omitted from the roll (section 4 of the *Electoral Act 1985*).

Foreign country

see definition in the Acts Interpretation Act 1901 (Commonwealth).

Foreign person

see definition in the *Foreign Acquisitions and Takeovers Act 1975* (Commonwealth).
