

Special Return for Large Gift

- This form is used by the agent of a registered political party to report a large gift.
- A large gift is one that has an amount or value of more than \$25,000 (section 130ZI(1) of the *Electoral Act 1985*).
- If the gift was received from an incorporated or unincorporated association, trust fund, funds of a foundation, or a body corporate then the agent must also provide 'prescribed particulars' of the donor as required by regulation 22(4)(b) of the *Electoral Regulations 2009*.
- This return must be lodged within 7 days of receipt of the large gift.
- This return must be accompanied by an Audit Certificate.
