

Appointment of an Agent for a Third party / Associated entity

A Third party or Associated entity may appoint an Agent. The Agent is responsible for the Third party or Associated entity's election funding, expenditure and financial disclosure obligations under Part 13A of the *Electoral Act 1985* (the Act). Only one Agent can be appointed at a time.

The name and address of a Third party/Associated entity's Agent will be entered into ECSA's Register of Agents.

During any period where no Agent is appointed of a registered Third party, each member of the executive committee of the organisation becomes responsible for the obligations of the Agent. If the Third party is a natural person, the Third party will be the Agent.

During any period where no Agent is appointed of an Associated entity, the financial controller of the Associated entity becomes responsible for the obligations of the Agent.

If no appointment is made prior to the close of nominations, the executive committee (Third party) or financial controller (Associated entity) will become the Agent.
