#### **Auditor comments**

##### **Matter 1**

A cash donation of \$50 received on 14 January 2026 was not deposited into the campaign bank account. Instead, the funds were spent on the same day on campaign-related activities.

##### **Matter 2**

A donation of USD \$50 was received on 13 January 2026 via the candidate's GoFundMe page from an overseas resident. The candidate inadvertently did not restrict overseas donations on this platform.

To address this matter, the funds were transferred from the campaign account to the candidate's personal bank account as part of the \$2,000 loan repayment made on 21 March 2026. Accordingly, these funds were not spent on campaign activities.

##### **Matter 3**

A donation of \$50 was received on 11 January 2026 via the candidate's PayPal account. The funds were transferred to the campaign account on 24 March 2026, after the return period.
