Notes

1. Forms RO 40A and RO 40B must be lodged with the Electoral Commission SA at least 48 hours prior to the hour of nomination.
2. A completed nomination form RO 40B for each endorsed candidate of the party should be lodged with this form.
3. A banker's cheque payable to the Electoral Commission of South Australia or an Electronic Funds Transfer (EFT) receipt for amount equal to the sum of deposits required for the party's endorsed candidates must be lodged with this form (refer to Form RO 106 for more information).
4. Voting ticket(s) must be lodged with the Electoral Commission SA within 72 hours from 12 noon of the day of the close of nominations.
5. How-to-vote cards for display in polling booths under section 66 of the *Electoral Act 1985* must be approved by the Electoral Commissioner and lodged with the Electoral Commission SA no later than 4 days after the day for nomination.
6. If a registered officer nominates a party-endorsed candidate with the Electoral Commission SA, no nomination for that candidate should be made to a House of Assembly Returning Officer.
