Notes

1. This booklet has been designed to enable a registered officer of a registered political party to lodge voting tickets on behalf of their endorsed candidate(s) for any or all House of Assembly districts.
2. To enable lodgement of voting tickets by the registered officer, the endorsed candidate(s) must have authorised this responsibility by completing the candidate's authorisation section of their nomination form RO 40B.
3. This form must reach the Electoral Commission SA within 72 hours from the hour of nomination.
4. Either 1 or 2 voting tickets may be lodged in respect to each candidate nominated.
5. The voting ticket must commence with the number 1 against the endorsed party candidate nominated for that district and then indicate by continuing consecutive numbers an order of preference for all candidates in the election.
6. Candidate names must be displayed on the voting ticket in the same order in which candidate names will appear on the ballot paper.
